This is an Open tender inviting online offers from reputed & experienced bidders (meeting [qualification criteria](#) as mentioned in Annexure - A & B) through E-procurement mode, for fabrication and Supply of Ceiling Girders for a quantum of 3948 MT $\pm 10\%$ for TANGEDCO Uppur and North Chennai project sites with vendor's materials [inclusive of Trial assembly, Blast cleaning & Painting, Transportation up to respective project sites (both sites located in Tamilnadu) as per BHEL Engg. drawings, Quality documents and Technical specifications.

1. This tender covers a tonnage of **3948 MT $\pm 10\%$** covering Ceiling Girders requirements for 2x800MW Uppur Units #1 & 2 and for 1x800 MW North Chennai project sites, both the project sites located in Tamilnadu.
2. This Tender quantum is divided into 2 Packages, as detailed below:
 - a. Package 1- CGUP (2632 MT) - **This Package is split into 2 Rate Schedules, CGUP1 & CGUP2 (Ceiling Girders for 2 Units of Uppur 2x800 MW), which will be distributed for ordering on 2 vendors as per tender ranking.**
 - b. Package 2 - CGNCH (1316 MT) - ***This entire quantum shall be ordered on one vendor as per tender ranking, for North Chennai 1x800MW.***
